This notice provides shareholders of the RiverNorth/DoubleLine Strategic Opportunity Fund, Inc. (NYSE: OPP) with important information concerning the distribution declared in October 2018. You are receiving this notice as a requirement of the Fund's managed distribution plan (Plan). The Board of Directors approved the implementation of the Plan to make monthly cash distributions to common shareholders, stated in terms of a fixed amount per common share. **This information is sent to you for informational purposes only** and is an estimate of the sources of the October distribution. It is not determinative of the tax character of the Fund's distributions for the 2018 calendar year.

The amounts and sources of distributions reported in this notice are estimates, are not being provided for tax reporting purposes and the distribution may later be determined to be from other sources including realized short-term gains, long-term gains, to the extent permitted by law, and return of capital.
