Dear RiverNorth/DoubleLine Strategic Opportunity Fund, Inc. Shareholder:

This notice provides shareholders of the RiverNorth/DoubleLine Strategic Opportunity Fund, Inc. (NYSE: OPP) with important information concerning the distribution declared in October 2018. You are receiving this notice as a requirement of the Fund's managed distribution plan (Plan). The Board of Directors approved the implementation of the Plan to make monthly cash distributions to common shareholders, stated in terms of a fixed amount per common share. **This information is sent to you for informational purposes only** and is an estimate of the sources of the December distribution. It is not determinative of the tax character of the Fund's distributions for the 2018 calendar year.

The amounts and sources of distributions reported in this notice are estimates, are not being provided for tax reporting purposes and the distribution may later be determined to be from other sources including realized short-term gains, long-term gains, to the extent permitted by law, and return of capital. The actual amounts and sources for tax reporting purposes will depend upon the Fund's investment experience during the remainder of its fiscal year and may be subject to changes based on tax regulations. The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes.

Distribution Period: December 2018
Distribution Amount per Common Share: \$0.1500

² Cumulative total return at NAV is the percentage change in the Fund's NAV for the period from the beginning of its fiscal year to December 31, 2018 including distributions paid and assuming reinvestment of those distributions.

The distribution rate should not be considered the dividend yield or total return on an investment in the Fund.
