*Statement Pursuant to Section 19(a)
of the Investment Company Act of 1940*

On December 31, 2019, the RiverNorth Opportunities Fund, Inc. (the “Fund”) paid a distribution of \$0.17 per share to shareholders of record at the close of business on December 17, 2019. In accordance with generally accepted accounting principles (“GAAP”), the Fund estimates that 48.18% is attributable to current year net investment income and the remaining is attributable to return of capital.

The timing and character of distributions for federal income tax purposes are determined in accordance with income tax regulations which may differ from GAAP. As such, all or a portion of this distribution may be reportable as taxable income on your 2019 federal income tax return. The final tax character of any distribution declared in 2019 will be determined in January 2020 and reported to you on IRS Form 1099-DIV.
