## Statement Pursuant to Section 19(a)

## of the Investment Company Act of 1940

On March 31, 2022, the RiverNorth Core Opportunity Fund (the "Fund") paid a distribution on its Class R and Class I shares of \$0.01825 and \$0.01979, respectively, per share to shareholders of record at the close of business on March 29, 2022. Under U.S. generally accepted accounting principles (GAAP), the Fund estimates that 100.00% of the distribution is attributable to return of capital.

The characterization of Fund distributions for federal income tax purposes is different from the GAAP characterization presented above. The determination of what portion of each year's distributions constitutes ordinary income, qualifying dividend income, short or long term capital gains or return of capital is reported to shareholders on the Fund's calendar year-end Form 1099-DIV.
