

## **RiverNorth Opportunities Fund, Inc.**

*Statement Pursuant to Section 19(a)  
of the Investment Company Act of 1940*

On April 29, 2022, the RiverNorth Opportunities Fund, Inc. (the “Fund”) paid a distribution of \$0.17 per share to shareholders of record at the close of business on April 14, 2022. In accordance with generally accepted accounting principles (“GAAP”), the Fund estimates that 16.26% is attributable to current year net investment income, 3.66% is attributable to short term capital gain and the remaining is attributable to return of capital.

The timing and character of distributions for federal income tax purposes are determined in accordance with income tax regulations which may differ from GAAP. As such, all or a portion of this distribution may be reportable as taxable income on your 2022 federal income tax return. The final tax character of any distribution declared in 2022 will be determined in January 2023 and reported to you on IRS Form 1099-DIV.
